#### **BACKGROUND:**

This is a temporary license agreement for the Ada County Sheriff's use of the 3rd runway paved area for emergency vehicle training and associated uses. The use must be pre-arranged and it is understood that an aviation or airport use of the premises takes priority. The agreement is subject to annual renewal (year to year).

**A RESOLUTION APPROVING A TEMPORARY LICENSE AGREEMENT BETWEEN THE CITY OF BOISE (DEPARTMENT OF AVIATION) AND ADA COUNTY FOR THE USE OF PREMISES UPON BOISE AIRPORT; RATIFYING AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AND ATTEST SAID LICENSE AGREEMENT ON BEHALF OF BOISE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Ada County wishes to temporarily use premises upon and within Boise Airport; and

**WHEREAS**, the Airport Director recommends approval of the Temporary License Agreement for such use as it is in the best interests of the City to enter into said Agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF BOISE CITY, IDAHO:**

**Section 1.** That the License Agreement for temporary use of said premises upon and within the Boise Airport, a copy of which is attached hereto marked Exhibit "A" and made a part hereof by attachment, be, and the same hereby is, approved both as to form and content.

**Section 2.** That the Mayor and City Clerk be, and they hereby are, authorized to respectively execute and attest said Temporary License Agreement for and on behalf of Boise City.

**Section 3.** That this Resolution shall be in full force and effect immediately upon its adoption and approval.


