SUBJECT: VA Fire Services Renewal FY18

BACKGROUND:

The current VA Contract for fire protection services in place with the City of Boise (approved by the City Council on January 5, 2016, in RES-10-16) expires on September 30, 2016, for the base year. The five (5) year contract represents FY16 - FY20, which includes four options for renewal. The VA sent an "Amendment of Solicitation/Modification of Contract" document for option year two (attached). The request is for a renewal or continuation of the same services in FY18 for fire protection services. BFD is satisfied that with the base rate (adjusted yearly) and cost recovery measures for major hazmat or technical rescue incidents. BFD will recoup all regular and potential expenses for this service.

Additional services requested, which will be provided as part of the contract price, include building and ground inspections (conducted through the Adopt-A-Building Program for the main building), fire prevention, public education and training activities in coordination with the VA Safety Officer, and hydrant inspections.

FINANCIAL IMPACT:

The VA will pay to the City \$148,184.00 for FY18 as Option Year Two. This is a 3.6% increase over FY16.

A RESOLUTION RATIFYING THE RENEWAL AGREEMENT (THIRD YEAR/OPTION YEAR TWO) OF THE FIVE YEAR CONTRACT BETWEEN THE CITY OF BOISE CITY, BY AND THROUGH THE BOISE FIRE DEPARTMENT, AND THE UNITED STATES GENERAL SERVICES ADMINISTRATION FOR FIRE PROTECTION SERVICES TO THE BOISE V.A. MEDICAL CENTER AND BOISE REGIONAL BENEFIT OFFICE THROUGH SEPTEMBER 30, 2018; AUTHORIZING AND RATIFYING THE CITY DESIGNEE'S EXECUTION OF THE RENEWAL AGREEMENT FOR OPTION YEAR ONE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Boise City and General Services Administration (GSA) have a history of contracting for Boise Fire Department fire protection services for the Boise V.A. Medical Center; and

WHEREAS, the GSA has requested the Boise Fire Department to continue providing such services in the third year of the five (5) year contract (option year two) to the Boise V.A. Medical Center and the Boise Regional Benefit Office; and

WHEREAS, the City of Boise City and the GSA wish to exercise the option to renew the contract for fire protection services for the third (3rd) year of the five (5) year term and approve the renewal executed by GSA and the Boise Fire Department's designee.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF BOISE CITY. IDAHO:

Section 1. That the Renewal Agreement for the contract between City of Boise Fire Department and the General Services Administration of the United States of America for fire protection services for the Boise V.A. Medical Center and Boise Regional Benefit Office, executed by GSA and the Boise Fire Department's designee, attached hereto and incorporated herein by reference, be, and the same is hereby, approved as to both form and content.

Section 2. That the Boise Fire Department's designee is hereby authorized to execute the Renewal Agreement, for and on behalf of the City of Boise City, and that the executed Renewal Agreement attached hereto is hereby ratified, for and on behalf of the City of Boise City.

Section 3. That this Resolution shall be in full force and effect immediately upon its adoption and approval.


