SUBJECT: CP 18-021: In-House Repair Parts and Management from NAPA: NJPA; NTE \$1,000,000.

BACKGROUND:

In 2009, the Fleet Department solicited proposals for an in-shop vendor staffed services for all repair parts and management. This contract has expired and all renewals have been exhausted. Fleet services would like to continue using this service through National Joint Powers Alliance (NJPA). National Joint Powers Alliance (NJPA) is a cooperative purchasing agency that has competitively bid a contract with NAPA IBS-Genuine Parts Company, contract number 061015-GPC, which provides in-shop, vendor-staffed services for all repair parts and management, and allows the City to use the resulting contract. This contract may be viewed by contacting Purchasing.

This request is to gain authorization to procure in house repair parts and management off of NJPA, Contract Number 061015-GPC from Napa IBS-Genuine Parts Company, not to exceed \$1,000,000.

RECOMMENDATION:

Finance and Administration and Fleet Services staff recommend authorization to procure CP 18-021 In-house Repair Parts and Management from NAPA IBS-Genuine Parts Company, off of National Joint Powers Alliance (NJPA), Contract Number 061015-GPC, not to exceed \$1,000,000.


