BACKGROUND:

Planning and Development Services, Housing and Community Development Division solicited bids for the exterior painting of 1025 Capitol, 1020 Lusk and 1028 Lusk.

BID RESULTS:

The bids were opened August 16, 2017, at 11:30am local time. Seven (7) companies received plan sets and were entered on the plan holders list. Two (2) bids were received. One (1) bid was deemed non-responsive.

Planning and Development Services, Housing and Community Development Division staff reviewed the bids for accuracy, completeness, and responsiveness. The lowest responsive bidder, Cheyenne Corporation dba AAA Action Painting, has been contacted by Planning and Development Services, Housing and Community Development Division staff, and indicated that they would like to proceed with the project.


