BACKGROUND:

The State of Idaho has a statewide contract with Dell Marketing, Idaho State Contracts PADD 16200012 & SBPO1388, which provides for computer equipment. This contract may be viewed at http://purchasing.idaho.gov/statewide_contracts.html.

This request is to gain authorization to procure equipment for citywide use off of Idaho State Contracts PADD 16200012 & SBPO1388 from Dell Marketing, not to exceed the computer equipment, software, and related services budget for FY18.

Finance and Administration staff anticipate that the purchases from Dell Marketing will exceed \$50,000.

RECOMMENDATION:

Finance and Administration staff recommend authorization to procure CP 18-011 computer equipment, software, and related services for citywide use from Dell Marketing off of Idaho State Contracts PADD 16200012 & SBPO1388, not to exceed the computer equipment budget for FY18.

This purchase is being made pursuant to Idaho Code § 67-2803(1) - Idaho State or Political Subdivision Contract.


