**BACKGROUND:**

The State of Idaho has a statewide contract with Microsoft Corporation, Idaho State Contract PADD 16200162, which provides for computer equipment. This contract may be viewed at:

This request is to gain authorization to procure equipment for citywide use off of Idaho State Contract PADD 16200162 from Microsoft Corporation, not to exceed the computer equipment budget for FY18.

Finance and Administration staff anticipate that the purchases from Microsoft Corporation will exceed \$50,000.

**RECOMMENDATION:**

Finance and Administration staff recommend authorization to procure CP 18-015 computer equipment, peripherals, and related services for citywide use from Microsoft Corporation off of Idaho State Contract PADD 16200162, not to exceed the computer equipment budget for FY18.

This purchase is being made pursuant to Idaho Code § 67-2803(1) - Idaho State or Political Subdivision Contract.


