BACKGROUND:

The State of Idaho has a statewide contract with DiscountCell, Inc., Idaho State Contract PADD 1520093, which provides for Wireless Cradlepoint Products and Services. This contract may be viewed at:

This request is to gain authorization to procure Wireless Cradlepoint Products and Services for citywide use off of Idaho State Contract PADD 1520093 from DiscountCell, Inc., not to exceed budget for FY18.

Finance and Administration staff anticipate that the purchases from DiscountCell, Inc. will exceed \$50,000.

RECOMMENDATION:

Finance and Administration staff recommend authorization to procure 17-018 Wireless Cradlepoint Products and Services from DiscountCell, Inc., off of Idaho State Contract PADD 1520093, not to exceed budget for FY18.


