BACKGROUND:

The State of Idaho has a statewide contract with Professional Police Supply Inc., Idaho State Contract SBPO 18200040, which provides for Police ammunition. This contract may be viewed at:

This request is to gain authorization to procure ammunition for Police use off of Idaho State Contract SBPO 18200040 from Professional Police Supply Inc., not to exceed ammunition budget for FY18.

Finance and Administration staff anticipate that the purchases from Professional Police Supply Inc. will exceed \$50,000.

RECOMMENDATION: Finance and Administration staff recommend authorization to procure CP 18-020 Ammunition for Police use from Professional Police Supply Inc., off of Idaho State Contract SBPO 18200040, not to exceed ammunition budget for FY18.


