SUBJECT: EX 17-422: IED On-Call Platinum Assurance Plan; Aviation Department; NTE \$59,204

BACKGROUND:

The IED Public Announcement Control system was installed at the Boise Airport in 2014. The warranty period for this equipment will expire on September 1, 2017. The IED Public Announcement Control system has been classified by the Airport as a 'Critical' system. This is the highest classification of support, meaning that the City of Boise Information Technology Airport staff will begin troubleshooting system issues within 1 hour of being dispatched by our Customer Service Center 24/7/365. In the case of a system failure, it would be difficult or impossible for tenants to perform their business for our customers and citizens. Additionally, the Boise Airport could potentially face reprimand or fines from the FAA if the PA system fails.

RECOMMENDATION:

Finance and Administration and Aviation Department staff recommend that EX 17-422 is awarded to IED Support Services, LLC, not to exceed \$59,204.00. Award of this contract is subject to compliance with bonding and insurance requirements.

FINANCIAL IMPACT:

Department has confirmed sufficient funding is available for this obligation.


