**BACKGROUND:**

The State of Idaho has a statewide contract with Baird Oil Company, Idaho State Contract SBPO 17200380, which provides for bulk fuel. This contract may be viewed at:

This request is to gain authorization to procure bulk fuel for citywide use off of Idaho State Contract SBPO 17200380 from Baird Oil Company, not to exceed bulk fuel budget for FY18.

Finance and Administration staff anticipate that the purchases from Baird Oil Company will exceed \$50,000.

**RECOMMENDATION:**

Finance and Administration staff recommend authorization to procure CP 18-005 bulk fuel for Citywide use from Baird Oil Company, off of Idaho State Contract SBPO 17200380, not to exceed bulk fuel budget for FY18.

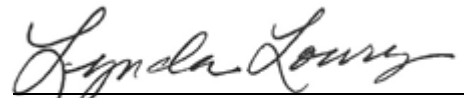
