BACKGROUND:

The City of Boise in partnership with several local agencies are working to increase mobility options. One such mobility project is a Park and Ride program for downtown employees and Boise State University (“BSU”) students. The City, the Capital City Development Corporation (“CCDC”), and BSU provide parking spaces in BSU’s satellite parking lot (located at 2891 Elder Street, Boise) and a bus shuttle service from the lot to downtown made available to BSU students and individuals working in the downtown corridor. This Park and Ride program is free to the users with CCDC and the City equally funding the program. Based on the on-going success of this program, the City, CCDC, and BSU desire to continue the program through Fiscal Year 2020.

RECOMMENDATION:

Department of Finance and Administration staff recommend that EX 18-397 be renewed for one (1) year, beginning October 1, 2019, and ending September 30, 2020, not to exceed \$210,840.00. This is the first (1st) of five (5) annual renewals allowed by the Agreement.

FINANCIAL IMPACT:

Department has confirmed sufficient funding is available for this obligation.

A RESOLUTION APPROVING THE RENEWAL OF EX 18-397, PARKING & SHUTTLE SERVICES, BETWEEN THE CITY OF BOISE (DEPARTMENT OF FINANCE AND ADMINISTRATION) AND BOISE STATE UNIVERSITY; AUTHORIZING THE MAYOR AND CITY CLERK TO RESPECTIVELY EXECUTE AND ATTEST SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Department of Finance and Administration staff recommended award of EX 18-397, Parking & Shuttle Services, to the best qualified proposer, Boise State University; and

WHEREAS, during their meeting of September 25, 2018, the City Council followed staff recommendation and awarded Resolution No. 440-18 to Boise State University; and

WHEREAS, the original Agreement contained a clause for renewal; and

WHEREAS, staff recommends the Agreement be renewed for a one-year period; and

WHEREAS, Boise State University has agreed to renew the contract under the terms and conditions as specified in the attached renewal letter; and

WHEREAS, this is the first (1st) of five (5) renewals allowed by the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF BOISE CITY, IDAHO:

Section 1. That the Renewal by and between the city of Boise City and Boise State University for EX 18-397, Parking & Shuttle Services, attached hereto and incorporated herein by reference, be, and the same is hereby, approved as to both form and content.

Section 2. That the Mayor and City Clerk be, and they hereby are, authorized to respectively execute and attest said Agreement for and on behalf of the city of Boise City.

Section 3. That this Resolution shall be in full force and effect immediately upon its adoption and approval.


